## **EASE Co-Pay Assistance Program: Terms and Conditions**

The EASE Co-Pay Assistance Program ("Co-Pay Program") provides eligible commercially insured patients financial assistance for out-of-pocket costs. Eligible commercially insured patients with a valid prescription may pay as little as **\$0 per month.** Annual and transactional limits apply. No other purchase necessary. The Co-Pay Program can be used only by eligible residents of the United States, Puerto Rico, Guam, or the Virgin Islands at participating pharmacies. Patients must be 18 years or older to participate in the Co-Pay Program or to activate the card on behalf of a minor.

The Co-Pay Program is not insurance. The Co-Pay Program is valid only for patients with commercial insurance and is not valid for prescriptions that are eligible to be reimbursed in whole or part, by Medicare, Medicaid, TRICARE, VA, DoD, the Puerto Rico Government Health Insurance Plan, or any other federal or state-funded healthcare benefit program (collectively, "Government Programs").

Patients who begin receiving prescription benefits from such Government Programs at any time will no longer be eligible to participate in the Co-Pay Program. Void where prohibited by law, taxed, or restricted.

The patient, or the patient's authorized representative on behalf of the patient, must personally enroll in the Co-Pay Program. Third party payers, including without limitation pharmacy benefit managers and their contactors and agents, are prohibited from requiring patients to enroll in the Co-Pay program and/or from assisting patients with enrolling in the Co-Pay Program.

This offer cannot be combined with any other coupon, free trial, discount, prescription savings card, or other offer (including any program offered by a third party payer or pharmacy benefit manager, or an agent of either, that adjusts patient cost-sharing obligations, sometimes called "accumulator" or "maximizer" programs). Exelixis reserves the right to reduce or eliminate the co-pay assistance available to patients enrolled in an insurance plan that utilizes an accumulator or maximizer program.

Co-Pay Program enrollment is limited to one per person and is not transferrable. It is illegal to sell, purchase, trade, or counterfeit, or offer to sell, purchase, trade, or counterfeit Co-Pay Program enrollment. Copay assistance provided under this program is offered to and intended for the sole benefit of eligible patients and may not be transferred to or utilized for the benefit of third parties, including, without limitation, third party payers and/or pharmacy benefit managers and their agents.

By redeeming this offer, the patient and pharmacist agree not to seek reimbursement for all or any part of the benefit received by the patient through the Co-Pay Program from any third party, such as insurance plans, flexible spending plans, or health savings accounts.
